- b. Please confirm that according to the RFP specifications, the RMS for the two contracts referenced in criterion 1.4.2 should have already been integrated with ASYCUDA in a PRODUCTION environment, i.e. whether it should be already in operation.
- c. This criterion is unduly restrictive, limiting or annulling competition and fairness in the procurement process. The objective of the RFP is to procure a Risk Management System for JCD. All such systems are customarily integrated with third systems or are delivered with other Customs subsystems (see question a), and are integrated with them. Requesting specifically integration with ASYCUDA, data warehouse, and licensing hub
- d. as part of the qualification criteria is very restrictive and even not necessary. Integration capabilities are standard features of RMS systems and should not be used as exclusion factors in a public bidding procedure; especially, when such procedures are funded by the World Bank, following its bidding rules. We respectfully request that MoPIC/JCD either remove the integration requirement from the qualification criteria or clarify that the references must concern RMS systems having the ability to integrate with other Customs subsystems. Indeed, proposers who can present references with their RMS system in productive operation and integrated with Import, Export, Transit, or with other "equivalent" systems in a broader ecosystem, like ASYCUDA, etc. should be considered acceptable. This adjustment will guarantee a fair and competitive process, in line with the rules of the WB, while ensuring the necessary integration capabilities.
